The North America segment businesses supply connections, oil country tubular goods (OCTG), subsea equipment, intervention tools, electronics and complex deep hole drilling and precision machining services for the United States, Canada and overseas markets. Its products and services include Perforating and Logging Systems; Connection Technology and OCTG; Subsea Technologies; Advanced Manufacturing; Well Intervention Equipment; Well Test and Process Systems and others.







Hunting PLC's cumulative annualized revenue growth rate over the charted period is -0.8%. This compares to cumulatative annualized growth of 14.1% over the past 3 years.



Hunting PLC's cumulative annualized EPS growth rate over the charted period is 32.1%. This compares to cumulatative annualized growth of 999.9% over the past 3 years.



Hunting PLC's net profit margin of 13.2% is 20.4% above the period's mean net margin of -7.3%. During the charted period, the observed net profit margin high and low were 13.2% and -37.6% respectively.



Hunting PLC's return on equity of 13.9% is 17.8% above the period's mean return on equity of -3.8%. During the charted period, the observed ROE high and low were 13.9% and -22.9% respectively.



Dividend Growth and Yield



Hunting PLC's trailing 12-month dividend per share is 0.08 and its dividend has grown at a cumulative annualized rate of 3.2% over the charted period. This compares to dividend growth of 18.90% over the past year and cumulative annualized growth of 27.10% over the past 3 years.



Hunting PLC's current dividend yield is 2.30% based on trailing 12 month dividends. The current yield is below the historically observed median of 2.56% and, over the charted time period, the observed high yield has been 5.31% and the observed low yield has been 0.48%.






EPS 5-Year Growth Rate %





Relative Strength Index - Relative Strength Index or RSI measures the magnitude of gains over a given time period against the magnitude of losses over that period. The equation is RSI = 100 - 100 / (1 + RS) where RS = (total gains / n) / (total losses / n) and n = number of RSI periods. In this item, 14 days is used and one year of daily prices are considered. A value of 30 or below may imply oversold and 70 or above may imply overbought.

Price Volatility - The standard deviation of the last 20 days of daily closing prices.

Sharpe Ratio - The 5 year average of the excess monthly return over the risk - free rate(1 - month T - bill) over the 5 year standard deviation of the same series.

Sortino Ratio - The same calculation as the Sharpe Ratio but with positive excess returns set to zero for the standard deviation denominator, so only negative volatility weighs in.

Dividends Per Share TTM - Sum of the last four quarters of Dividends Per Share.

Payout Ratio - Dividends Per Share TTM divided by Operating EPS TTM.

Dividend Yield TTM % - Sum of the last four quarter of Dividends Per Share divided by Weekly Price.

EBITDA - Sum of the last four quarters of EBITDA (Operating Income + Depreciation & Amortization).

Free Cash Flow - Sum of the last four quarters Net Cash from Operations minus Capital Expenditures (Purchase of Property, Plant & Equipment), from the Cash Flow Statement.

Book Value Per Share - Total Common Equity last quarter divided by Shares Outstanding last quarter.

Gross Margin % - Sum of the last four quarters Gross Profit divided by the sum of the last four quarters Revenues.

EBITDA Margin % - Sum of the last four quarters EBITDA divided by the sum of the last four quarters Revenues.

Pre-Tax Margin % - Sum of the last four quarters of Earnings Before Taxes divided by sum of the last four quarters Revenues.
