Kier Group plc is a provider of construction, infrastructure and property developments in the United Kingdom (UK). Its segments include Infrastructure Services, Construction, and Property. The Infrastructure Services segment is a provider of infrastructure, working collaboratively with its customers and supply chain. It also works in partnership with central government departments, regional and local authorities and regulated utilities. Under the Construction segment, it operates as a national contractor delivering projects of all sizes and complexities in the public and private sectors, including education, healthcare, defense and justice and borders. It designs and delivers buildings from hospitals and treatment centers, to schools, leisure centers, and prisons. Under the Property segment, it invests in and develops sites, acting as a mixed-use commercial and residential developer specializing in urban regeneration, last mile logistics and modern sustainable office developments.

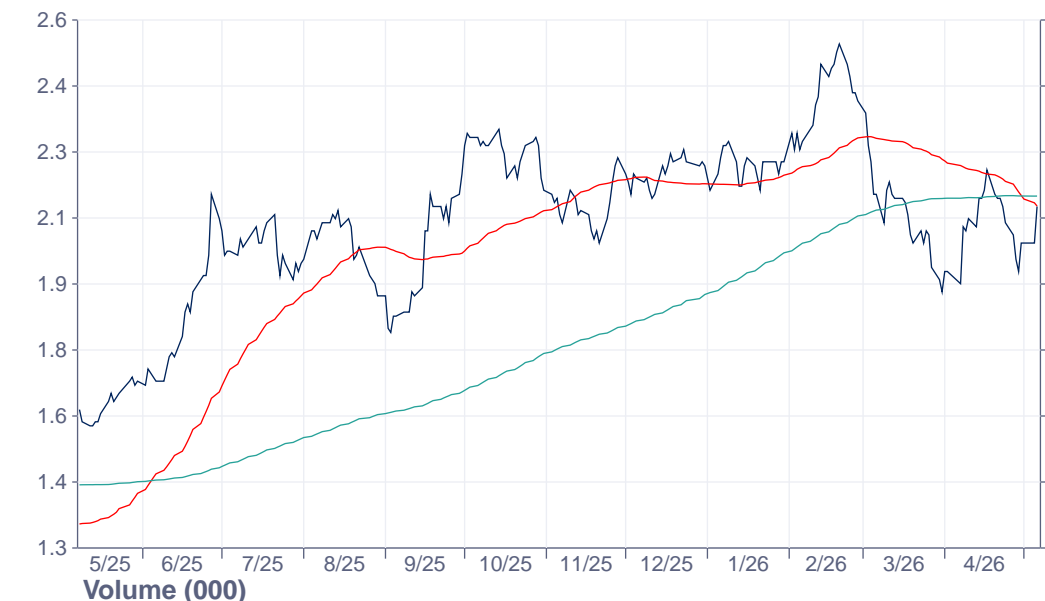

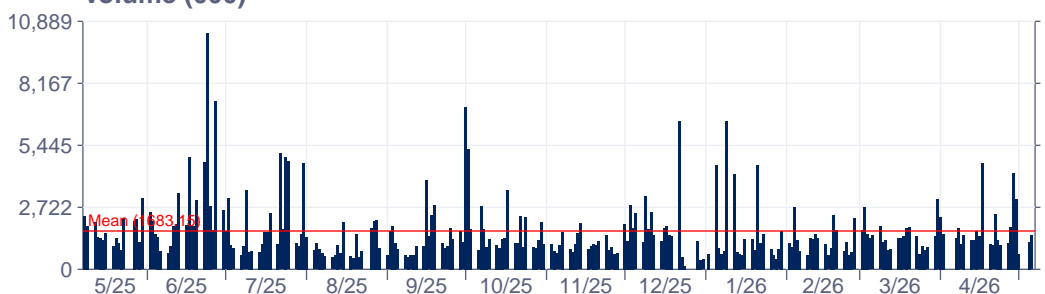
Price, Moving Averages & Volume

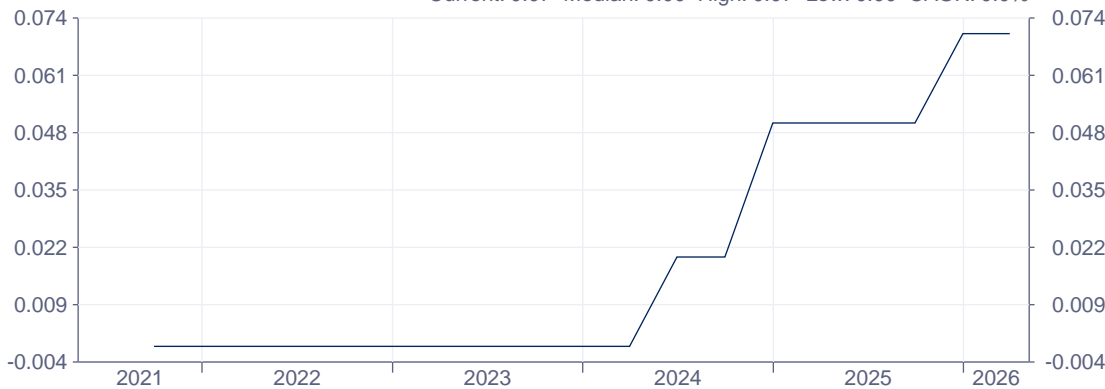

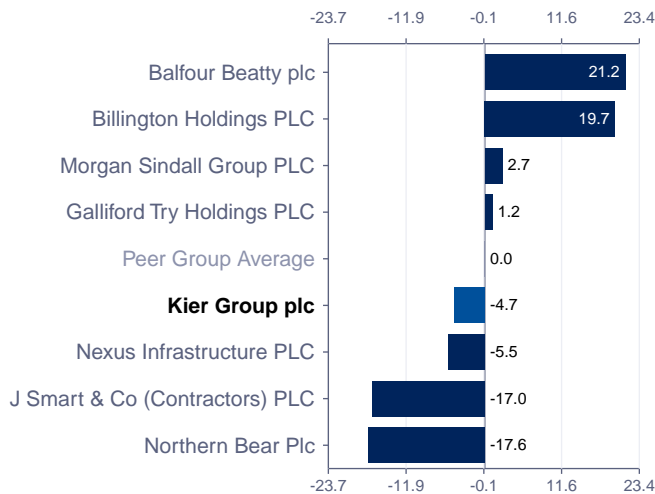

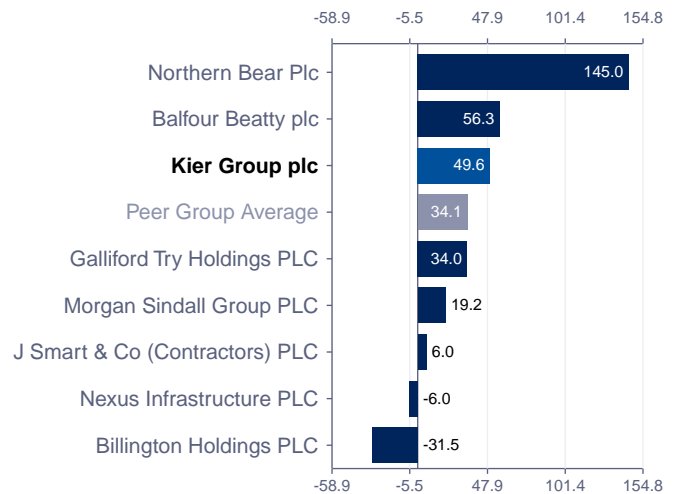

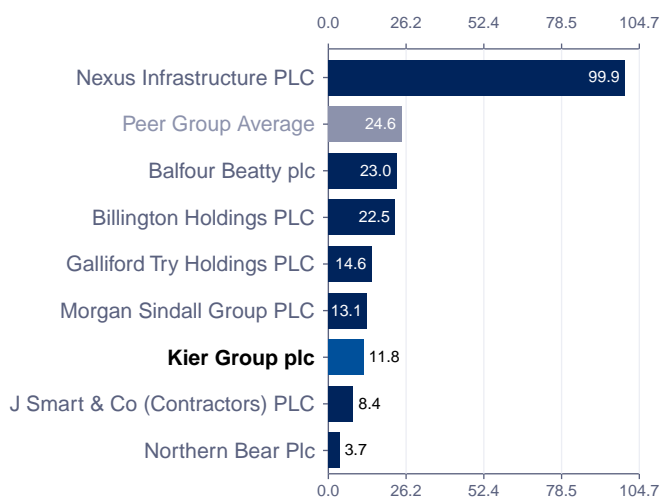
Price Change Year to Date %



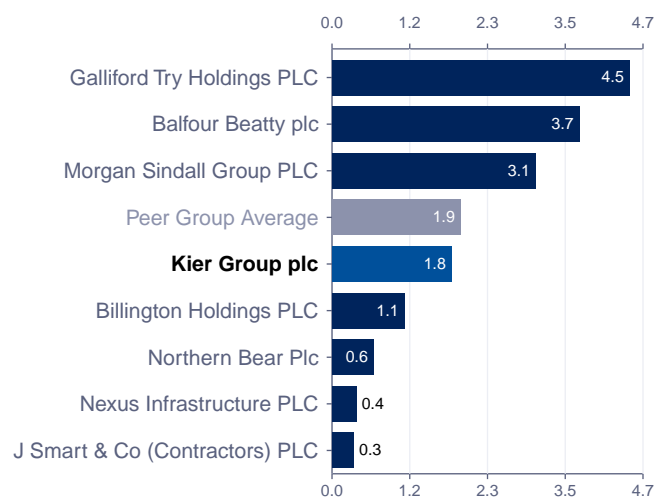
Price Change Last Calendar Year %



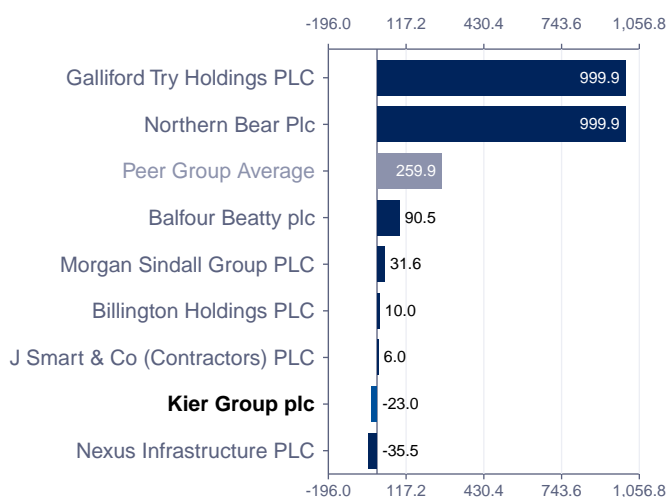
Price / EPS TTM



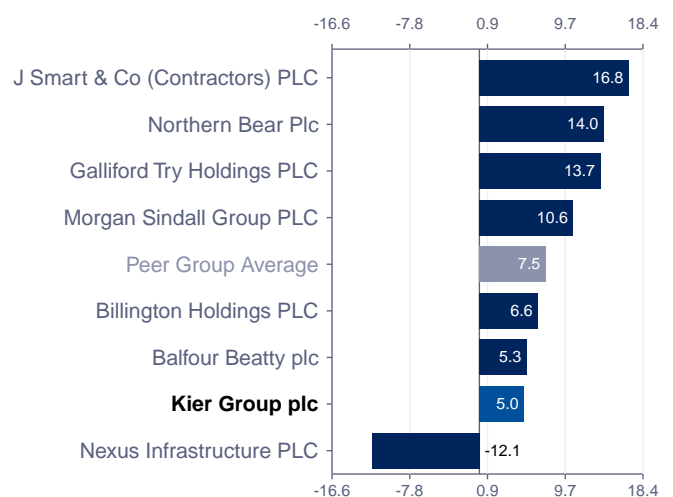
Price / Book Value

In this item, 14 days is used and one year of daily prices are considered. A value of 30 or below may imply oversold and 70 or above may imply overbought.
Price Volatility	- The standard deviation of the last 20 days of daily closing prices.
Sharpe Ratio	- The 5 year average of the excess monthly return over the risk - free rate(1 - month T - bill) over the 5 year standard deviation of the same series.
Sortino Ratio	- The same calculation as the Sharpe Ratio but with positive excess returns set to zero for the standard deviation denominator, so only negative volatility weighs in.
