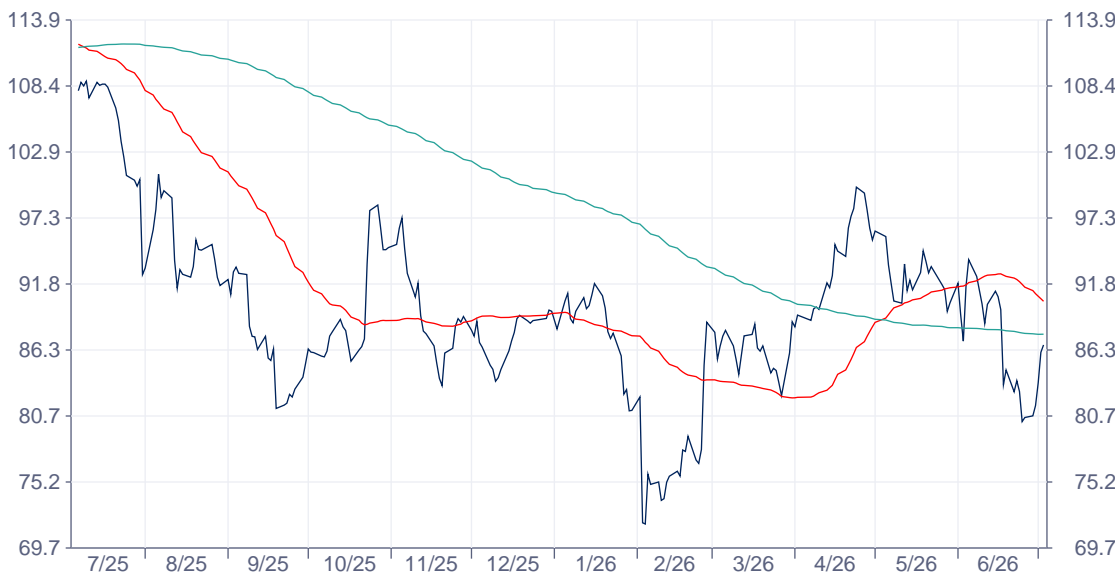

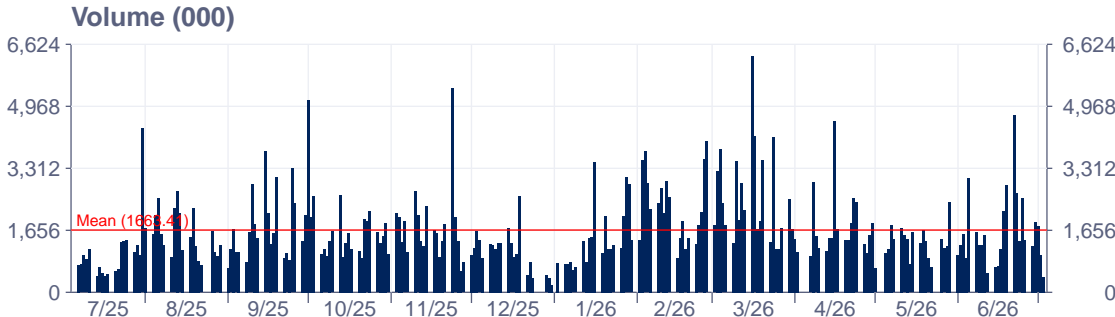
Price, Moving Averages & Volume

LSEG:LN is currently 20.3% below its 52-week high price of 108.80 and is 20.9% above its 52-week low price of 71.70. Over the past 52-weeks, LSEG:LN is down 19.0% while on a calendar year-to-date basis it is down 3.2%.

The Relative Strength Index (RSI) indicator for LSEG:LN is currently 50.49. An RSI value of 70 and above is considered overbought and 30 and below oversold.

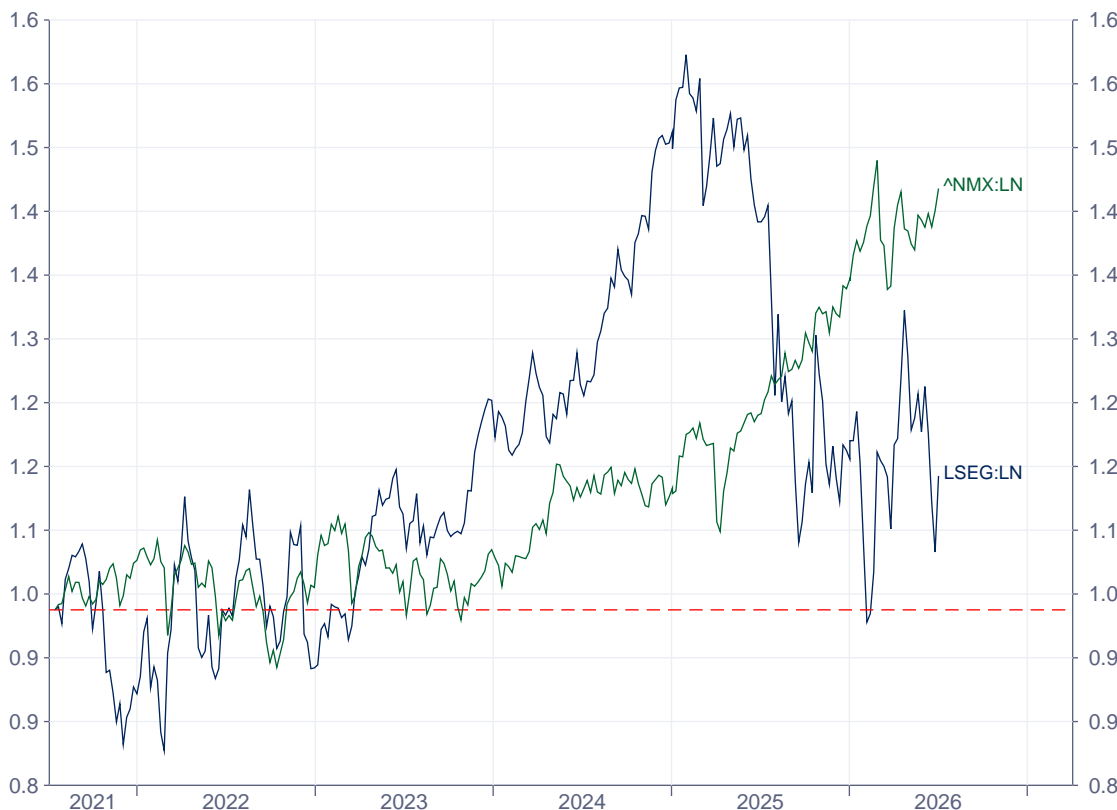

London Stock Exchange Group Plc's cumulative annualized growth rate (CAGR) over the five year period has been 2.7% while that of the FTSE 350 Index has been 7.7%.

Over the past year, London Stock Exchange Group Plc's stock price performance of -19.0% has underperformed that of the FTSE 350 Index by 38.6%. On a year-to-date basis, London Stock Exchange Group Plc's stock price performance of -3.1% has underperformed the FTSE 350 Index by 10.4%.

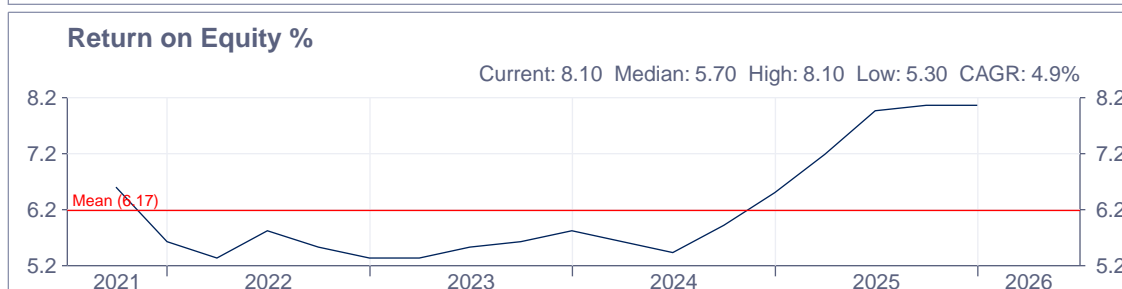

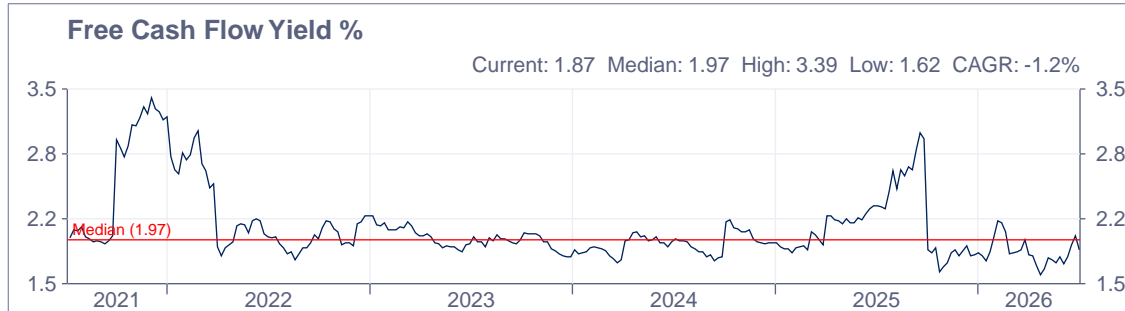

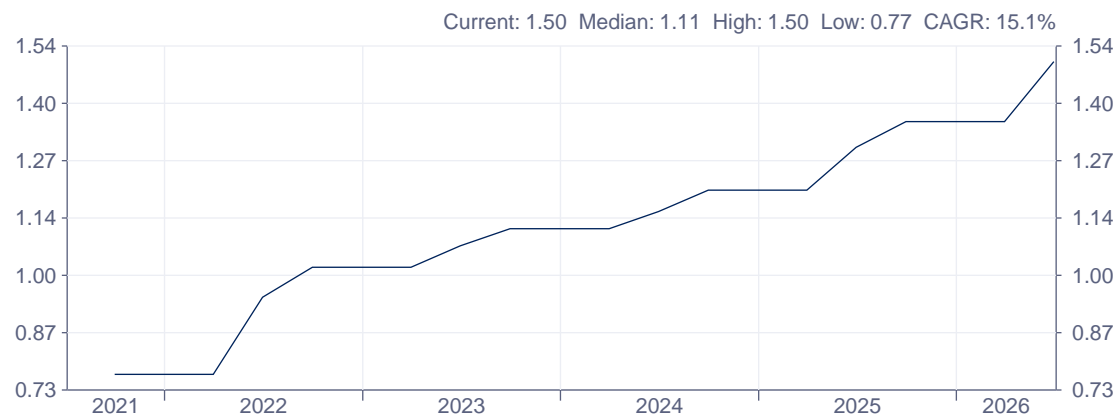

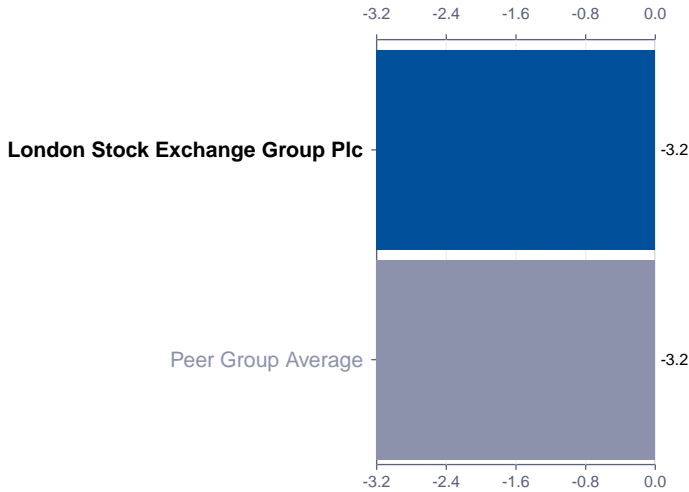
Dividend Yield TTM %



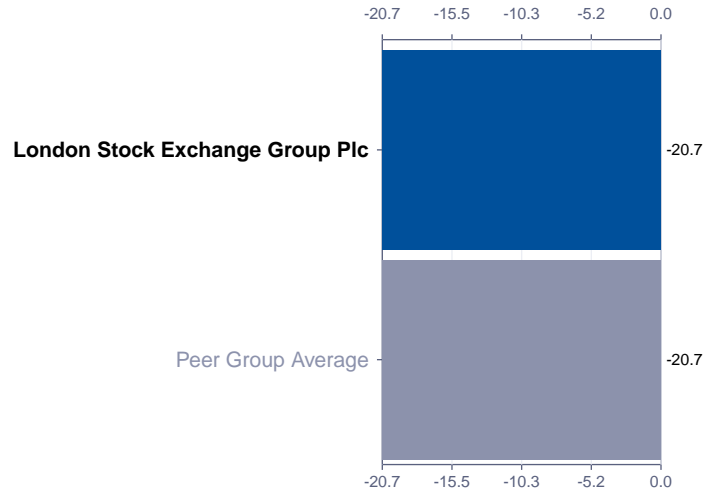

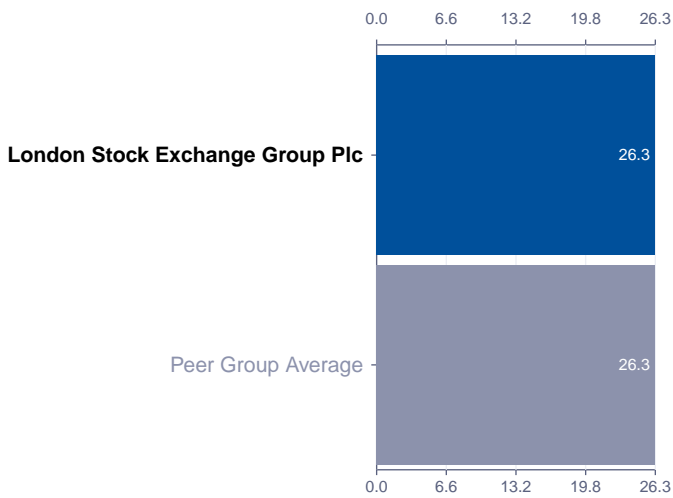
Price Change Year to Date %



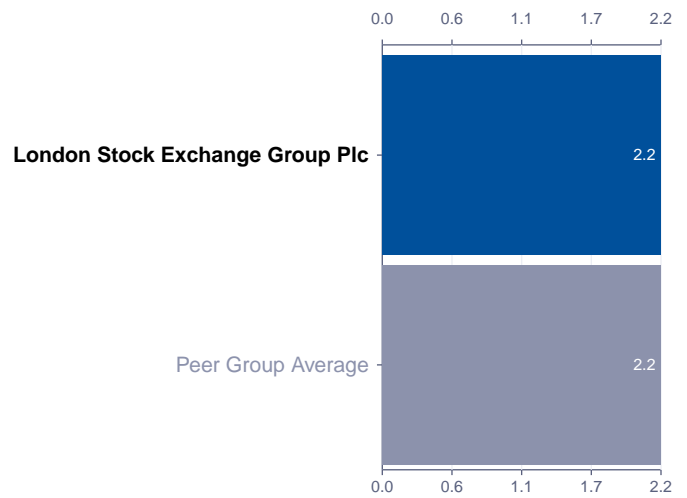
Price Change Last Calendar Year %



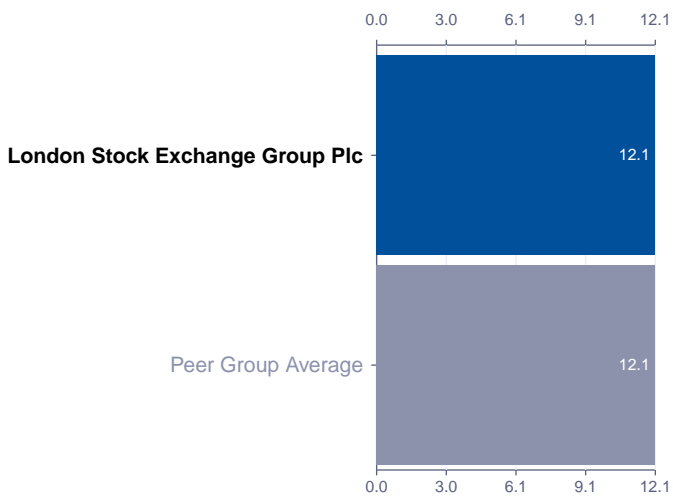
Price / EPS TTM



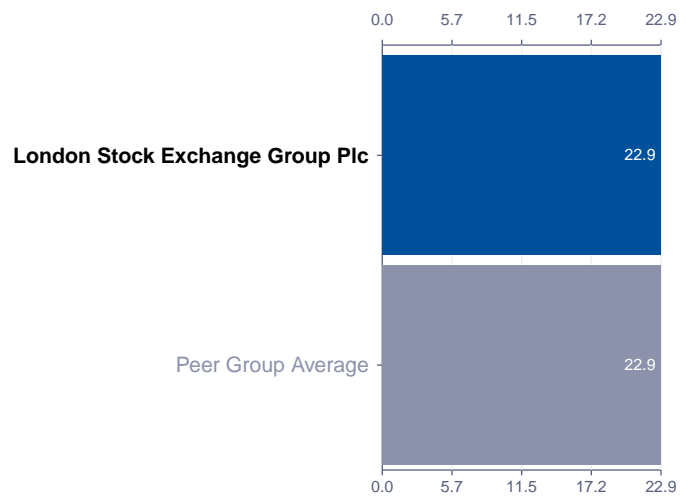
Price / Book Value

In this item, 14 days is used and one year of daily prices are considered. A value of 30 or below may imply oversold and 70 or above may imply overbought.
Price Volatility	- The standard deviation of the last 20 days of daily closing prices.
Sharpe Ratio	- The 5 year average of the excess monthly return over the risk - free rate(1 - month T - bill) over the 5 year standard deviation of the same series.
Sortino Ratio	- The same calculation as the Sharpe Ratio but with positive excess returns set to zero for the standard deviation denominator, so only negative volatility weighs in.
Dividends Per Share TTM	- Sum of the last four quarters of Dividends Per Share.
Payout Ratio	- Dividends Per Share TTM divided by Normalized EPS TTM.
Dividend Yield TTM %	- Sum of the last four quarter of Dividends Per Share divided by Weekly Price.
EBITDA	- Sum of the last four quarters of EBITDA (Operating Income + Depreciation & Amortization).
Free Cash Flow	- Sum of the last four quarters Net Cash from Operations minus Capital Expenditures (Purchase of Property, Plant & Equipment), from the Cash Flow Statement.
Book Value Per Share	- Total Common Equity last quarter divided by Shares Outstanding last quarter.
