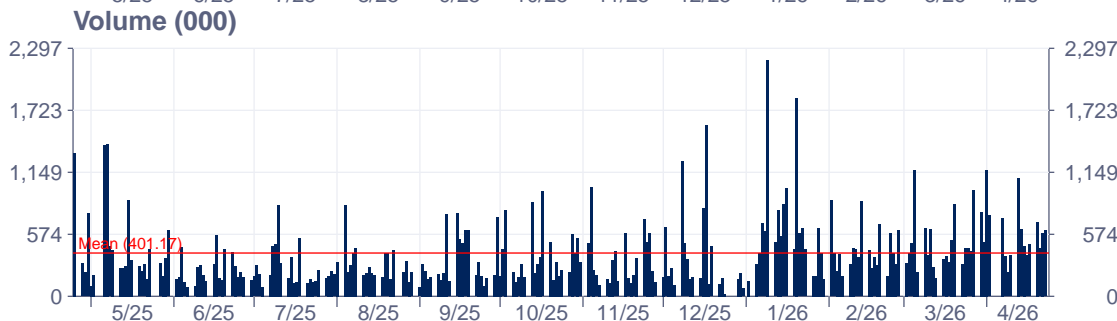
## Price, Moving Averages & Volume

NXT:LN is currently 7.4% below its 52-week high price of 142.04 and is 16.6% above its 52-week low price of 112.77. Over the past 52-weeks, NXT:LN is up 13.5% while on a calendar year-to-date basis it is down 1.3%.

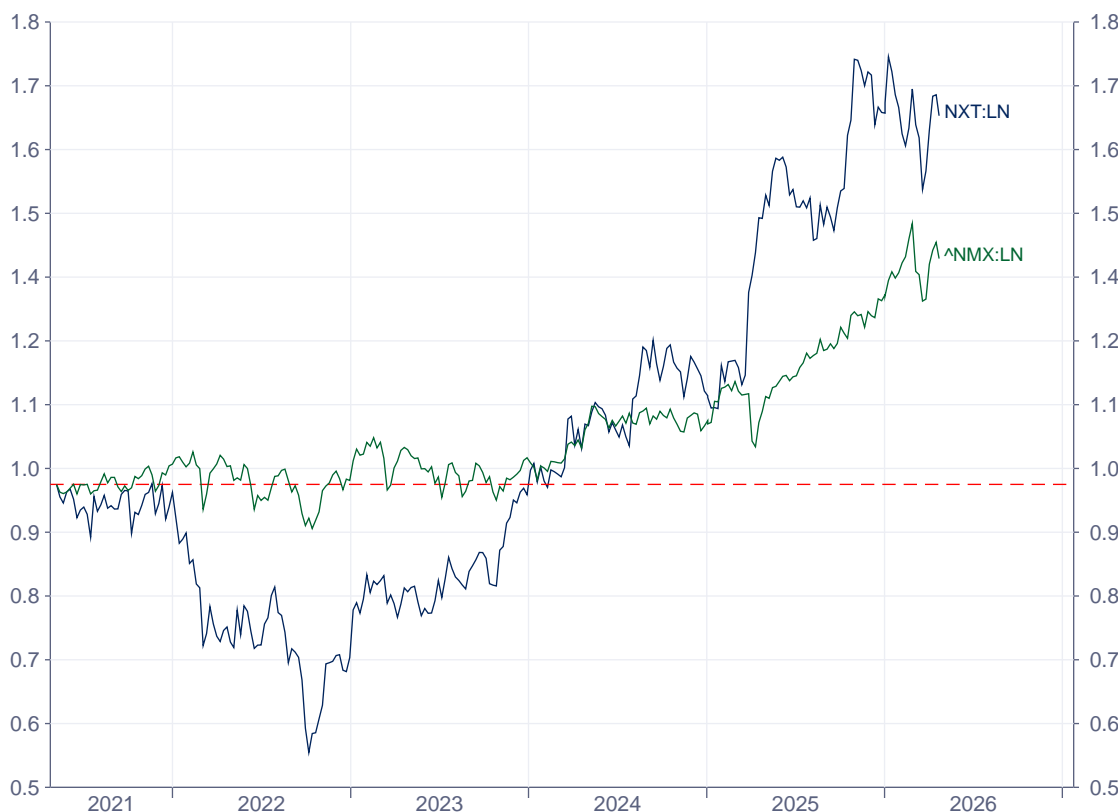

Over the past five years, NEXT plc's stock price is up 63.3% which is 24.5% above the FTSE 350 Index performance of 38.8% over the same period. NEXT plc's cumulative annualized growth rate (CAGR) over the five year period has been 10.4% while that of the FTSE 350 Index has been 6.8%.

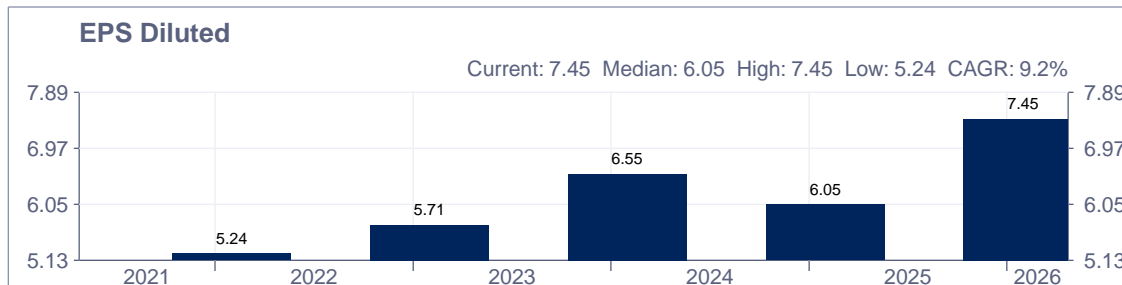
Over the past week, NEXT plc's stock price performance of -2.1% has underperformed that of the FTSE 350 Index by 1.0%.

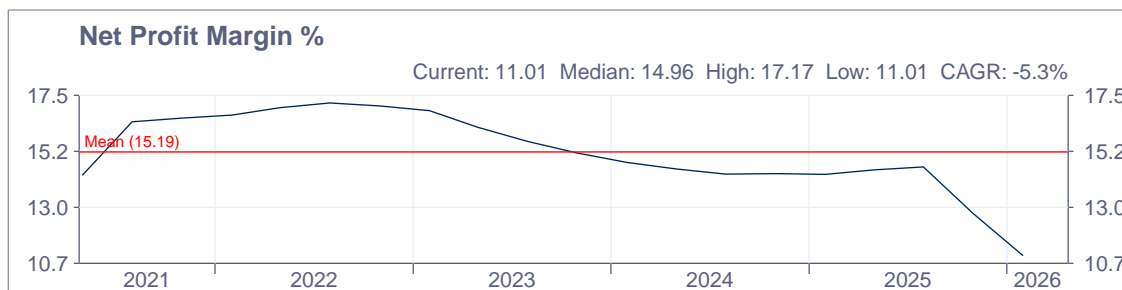

NEXT plc's cumulative annualized revenue growth rate over the charted period is 10.5%. This compares to cumulative annualized growth of 11.1% over the past 3 years.



NEXT plc's cumulative annualized EPS growth rate over the charted period is 9.2%. This compares to cumulative annualized growth of -1.9% over the past 3 years.



NEXT plc's net profit margin of 11.0% is 4.2% below the period's mean net margin of 15.2%. During the charted period, the observed net profit margin high and low were 17.2% and 11.0% respectively.



NEXT plc's return on equity of 46.7% is 28.8% below the period's mean return on equity of 75.5%. During the charted period, the observed ROE high and low were 100.0% and 46.7% respectively.

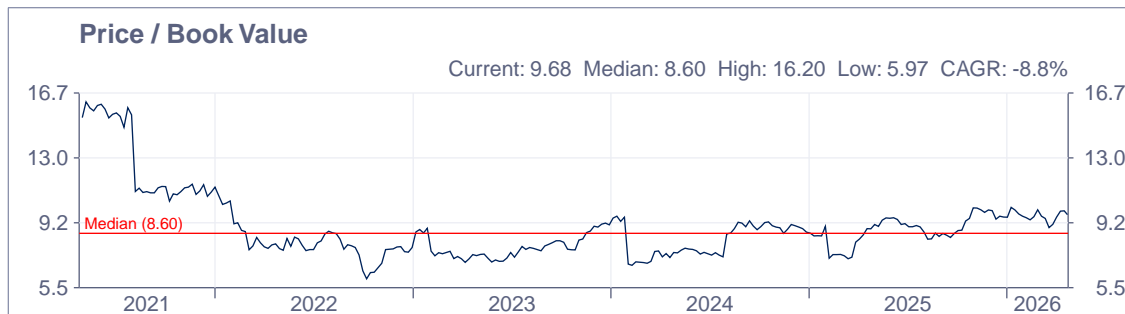

NEXT plc is trading at 20.70 times its EPS generated during the latest fiscal year. This multiple is above the historically observed median of 13.25, while high and low observations have been 23.95 and 6.65.



NEXT plc is trading at a Price to Sales ratio of 2.28 based on sales generated during the latest fiscal year. This ratio is above the historically observed median ratio of 1.94, while high and low observations have been 2.78 and 1.14.



NEXT plc is trading at a Price to Book ratio of 9.68 based on book value at the latest fiscal year end. This ratio is above the historically observed median of 8.60, while high and low observations have been 16.20 and 5.97.



NEXT plc has a Free Cash Flow Yield of 3.36% based on free cash flow generated during the latest fiscal year. This value is below the historically observed median yield of 3.76%, while high and low observations have been 5.46 and 2.26.

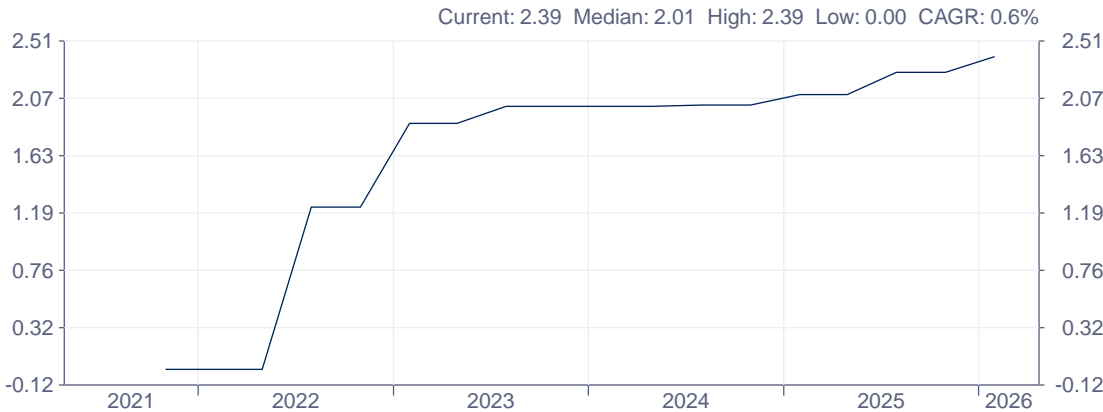

NEXT plc's trailing 12-month dividend per share is 2.39 and its dividend has grown at a cumulative annualized rate of 0.6% over the charted period. This compares to dividend growth of 17.10% over the past year and cumulative annualized growth of 9.80% over the past 3 years.

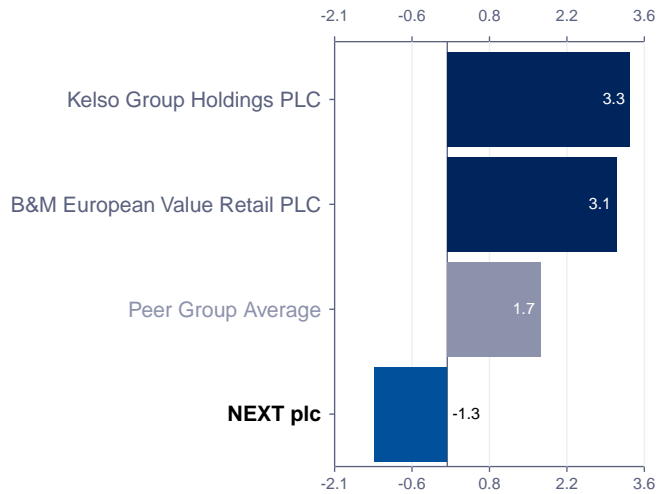
### Dividend Yield TTM %



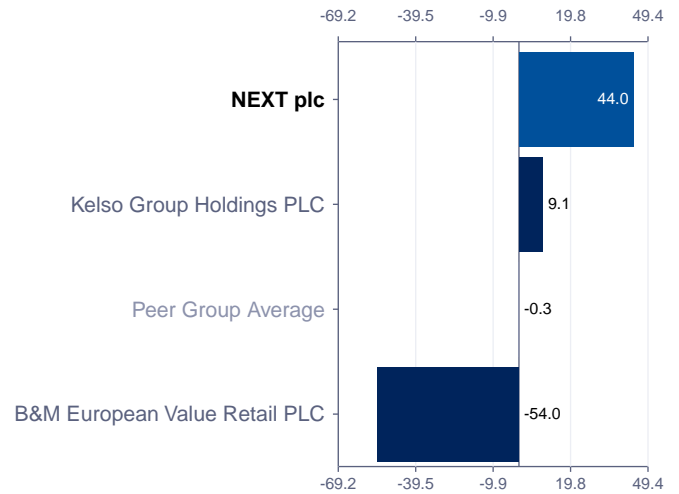

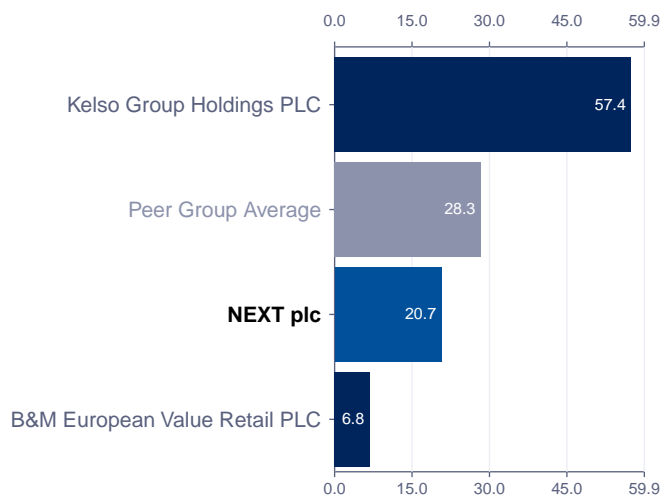
### Price Change Year to Date %



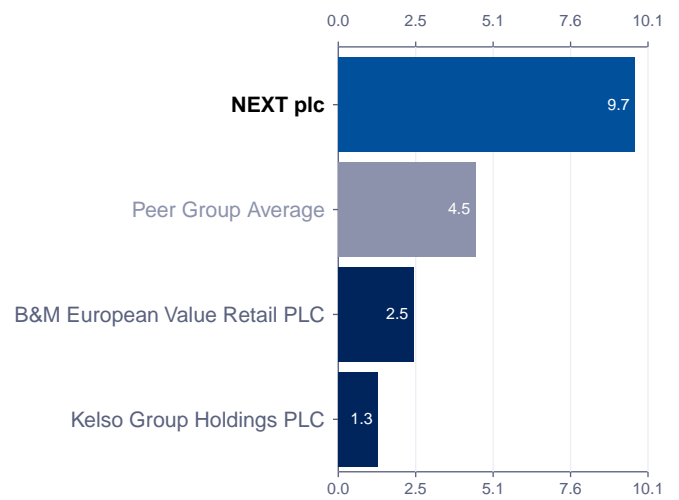
### Price Change Last Calendar Year %



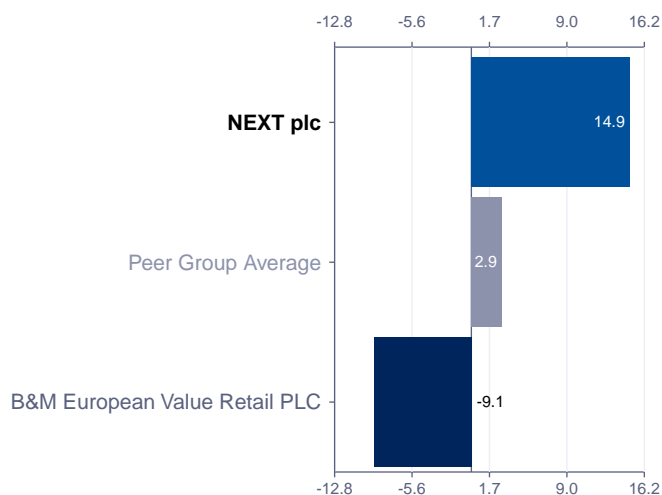
### Price / EPS TTM



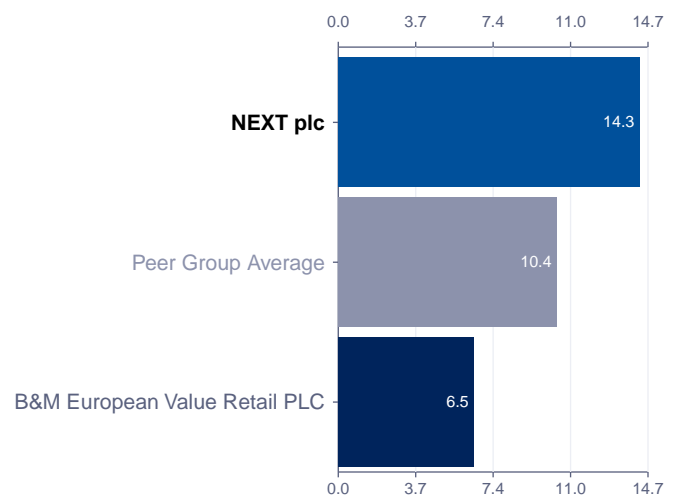
### Price / Book Value

In this item, 14 days is used and one year of daily prices are considered. A value of 30 or below may imply oversold and 70 or above may imply overbought.
<b>Price Volatility</b>	- The standard deviation of the last 20 days of daily closing prices.
<b>Sharpe Ratio</b>	- The 5 year average of the excess monthly return over the risk - free rate(1 - month T - bill) over the 5 year standard deviation of the same series.
<b>Sortino Ratio</b>	- The same calculation as the Sharpe Ratio but with positive excess returns set to zero for the standard deviation denominator, so only negative volatility weighs in.

<b>EBITDA</b>	- Sum of the last four quarters of EBITDA (Operating Income + Depreciation & Amortization).
<b>Free Cash Flow</b>	- Sum of the last four quarters Net Cash from Operations minus Capital Expenditures (Purchase of Property, Plant & Equipment), from the Cash Flow Statement.
<b>Book Value Per Share</b>	- Total Common Equity last quarter divided by Shares Outstanding last quarter.
<b>Gross Margin %</b>	- Sum of the last four quarters Gross Profit divided by the sum of the last four quarters Revenues.
