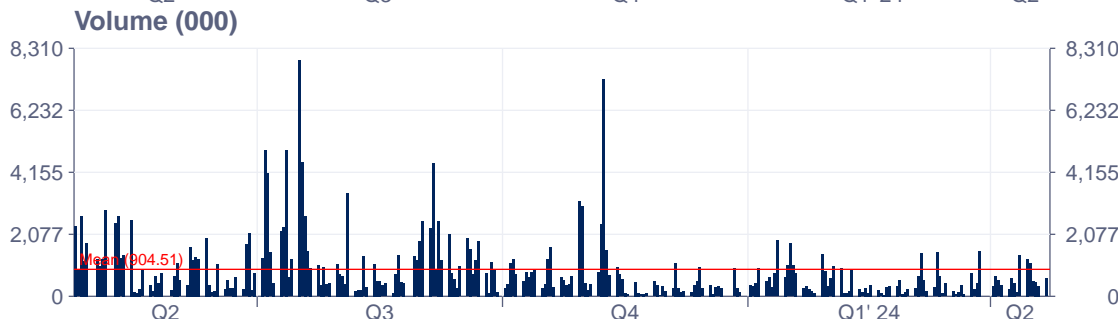
## Price, Moving Averages & Volume

RBW:LN is currently 41.5% below its 52-week high price of 17.00 and is 28.4% above its 52-week low price of 7.75. Over the past 52-weeks, RBW:LN is up 9.3% while on a calendar year-to-date basis it is down 22.0%.

The equation is $RSI = 100 - 100 / (1 + RS)$ where $RS = (total\ gains / n) / (total\ losses / n)$ and $n =$ number of RSI periods. In this item, 14 days is used and one year of daily prices are considered. A value of 30 or below may imply oversold and 70 or above may imply overbought.
<b>Price Volatility</b>	- The standard deviation of the last 20 days of daily closing prices.
<b>Sharpe Ratio</b>	- The 5 year average of the excess monthly return over the risk - free rate(1 - month T - bill) over the 5 year standard deviation of the same series.
<b>Sortino Ratio</b>	- The same calculation as the Sharpe Ratio but with positive excess returns set to zero for the standard deviation denominator, so only negative volatility weighs in.
<b>Dividends Per Share TTM</b>	- Sum of the last four quarters of Dividends Per Share.
<b>Payout Ratio</b>	- Dividends Per Share TTM divided by Operating EPS TTM.
<b>Dividend Yield TTM %</b>	- Sum of the last four quarter of Dividends Per Share divided by Weekly Price.
<b>EBITDA</b>	- Sum of the last four quarters of EBITDA (Operating Income + Depreciation & Amortization).
<b>Free Cash Flow</b>	- Sum of the last four quarters Net Cash from Operations minus Capital Expenditures (Purchase of Property, Plant & Equipment), from the Cash Flow Statement.
<b>Book Value Per Share</b>	- Total Common Equity last quarter divided by Shares Outstanding last quarter.
<b>Gross Margin %</b>	- Sum of the last four quarters Gross Profit divided by the sum of the last four quarters Revenues.
<b>EBITDA Margin %</b>	- Sum of the last four quarters EBITDA divided by the sum of the last four quarters Revenues.
<b>Pre-Tax Margin %</b>	- Sum of the last four quarters of Earnings Before Taxes divided by sum of the last four quarters Revenues.
<b>Net Profit Margin %</b>	- Sum of the last four quarters of Operating EPS divided by sum of the last four quarters Revenues Per Share.
<b>Return on Equity %</b>	- Sum of the last four quarters of Operating EPS divided by the average of the last four quarters Book Value.
