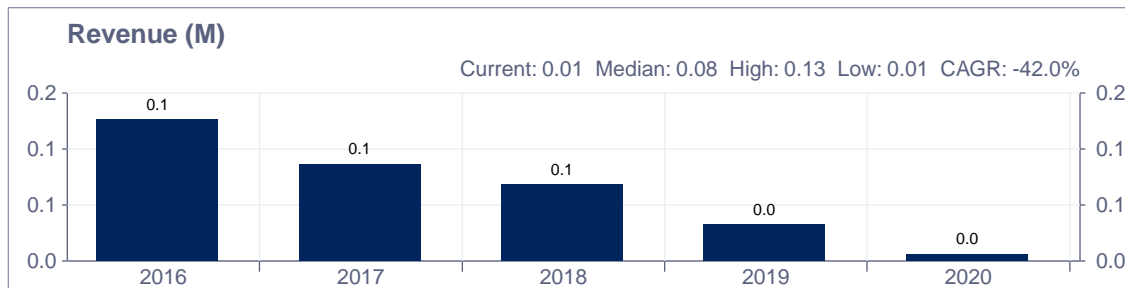

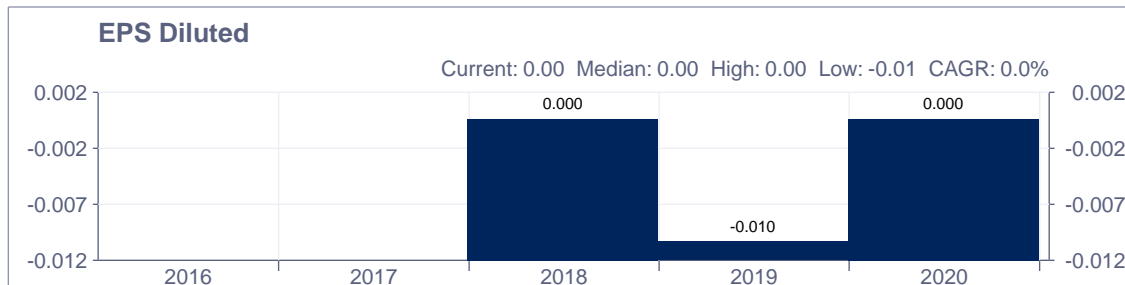

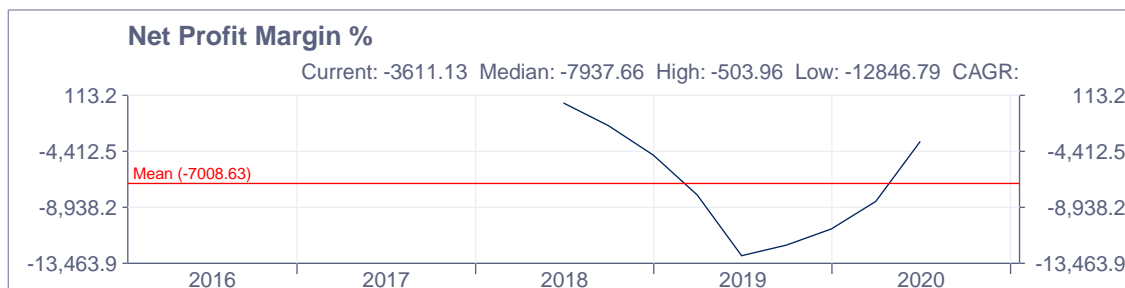

Red Emperor Resources NL's cumulative annualized revenue growth rate over the charted period is -42.0%. This compares to revenue growth of -63.4% last fiscal year and cumulative annualized growth of -45.8% over the past 3 years.



Red Emperor Resources NL's cumulative annualized EPS growth rate over the charted period is 0.0%. This compares to EPS growth of 9.3% last fiscal year and cumulative annualized growth of % over the past 3 years.

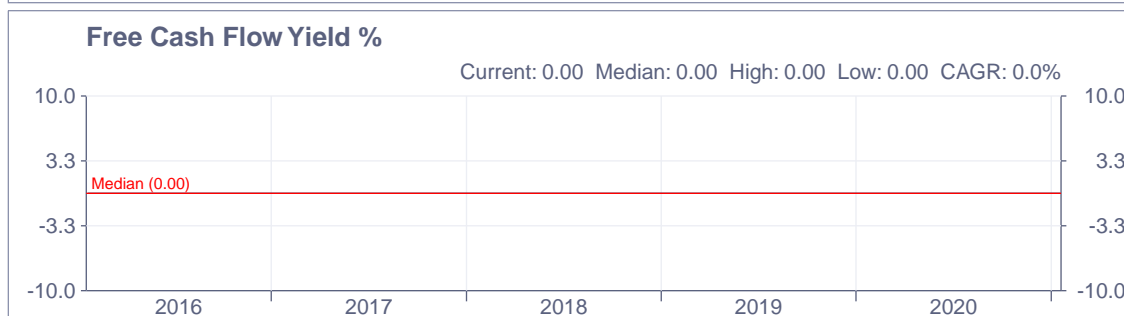

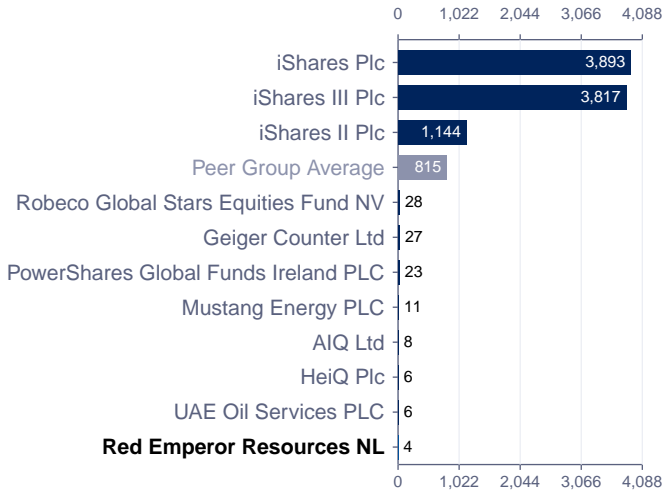

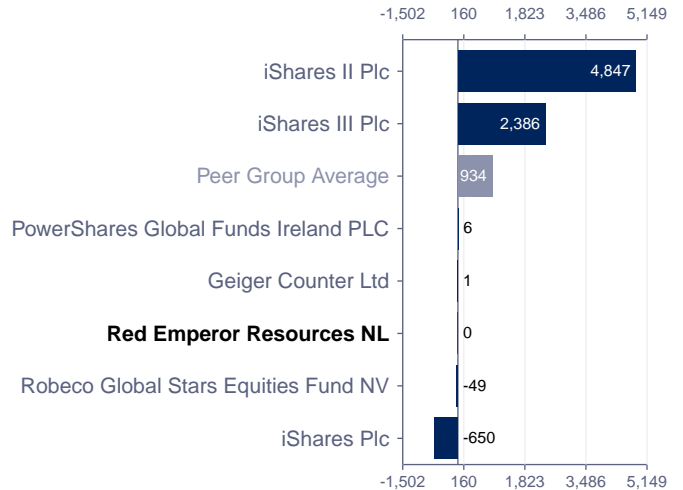

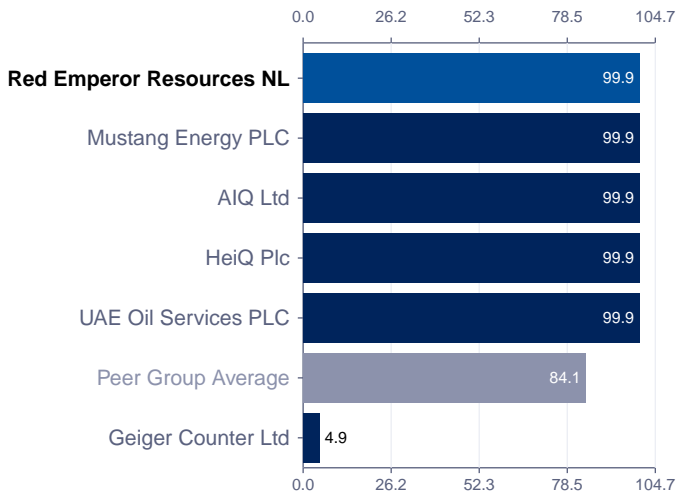
Market Value (M)



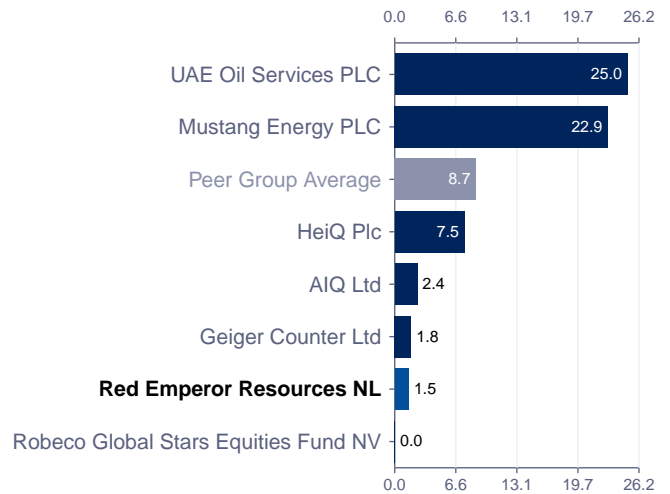
Revenue LFY (M)



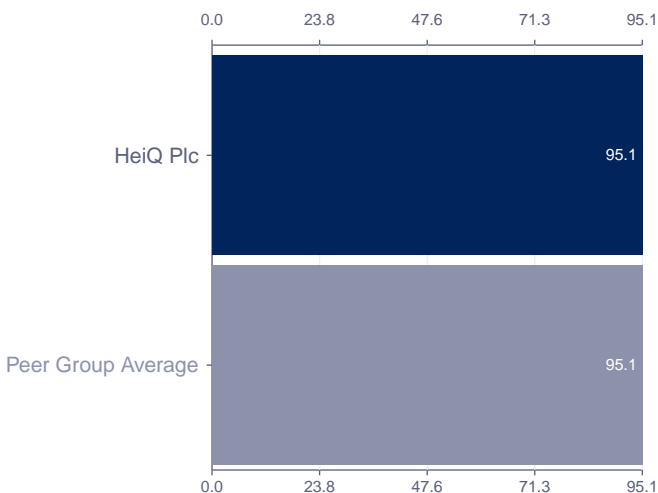
Price / EPS TTM



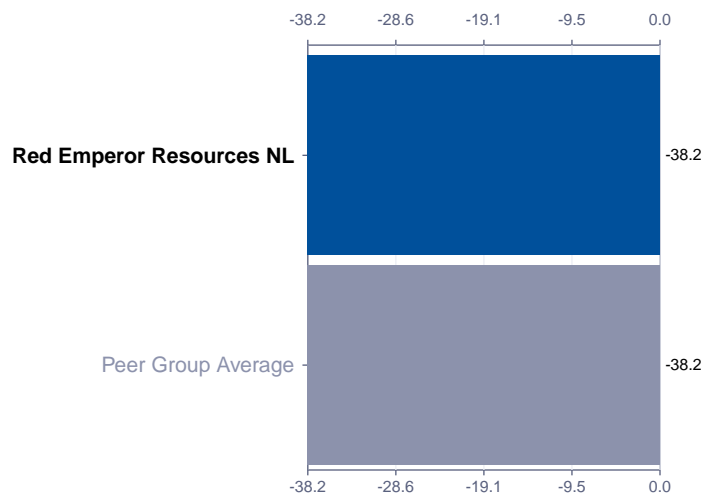
Price / Book Value

Sharpe Ratio	- The 5 year average of the excess monthly return over the risk - free rate(1 - month T - bill) over the 5 year standard deviation of the same series.
Sortino Ratio	- The same calculation as the Sharpe Ratio but with positive excess returns set to zero for the standard deviation denominator, so only negative volatility weighs in.
Dividends Per Share TTM	- Sum of the last four quarters of Dividends Per Share.
