Frasers Group PLC is a sporting goods retailer. The Company's segments include UK Sports, Premium Lifestyle, International, Property, and Financial Services. The UK Sports segment include core sports retail store operations in the United Kingdom, plus all the Company's sports retail online business, other United Kingdom-based sports retail and wholesale operations, GAME UK stores and online operations, retail store operations in Northern Ireland, and Frasers Fitness. The Premium Lifestyle segment includes the Company's premium and luxury retail businesses FLANNELS, Cruise, Van Mildert, Jack Wills, House of Fraser, Gieves and Hawkes, and Sofa.com. International segment includes Company's sports retail stores, management and operating functions in Europe, Asia and the rest of the world. The Property segment include freehold property owning and long leasehold holding property companies. The Financial services include interest charged on amounts advanced to consumer credit customers.

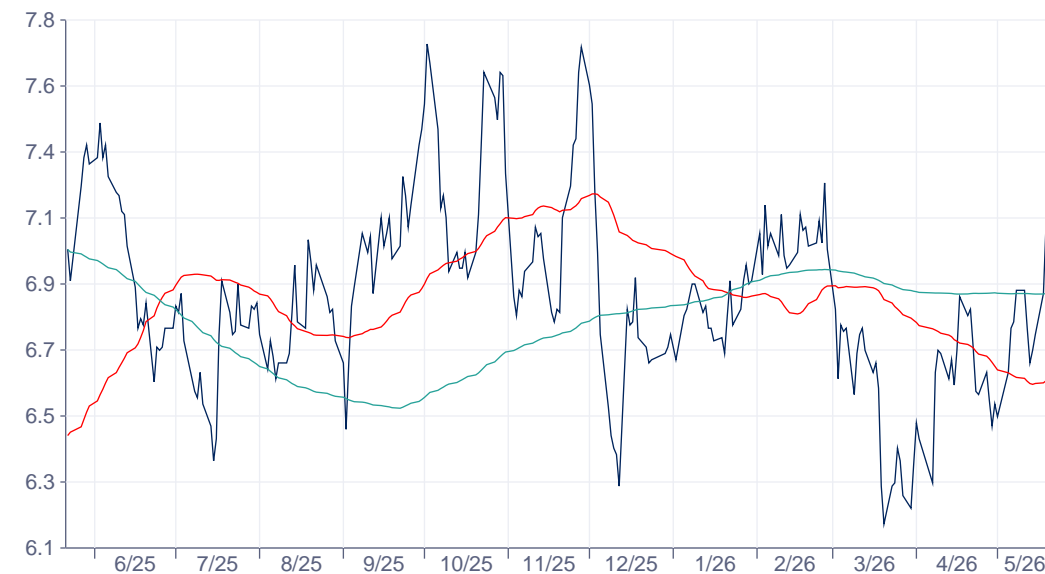

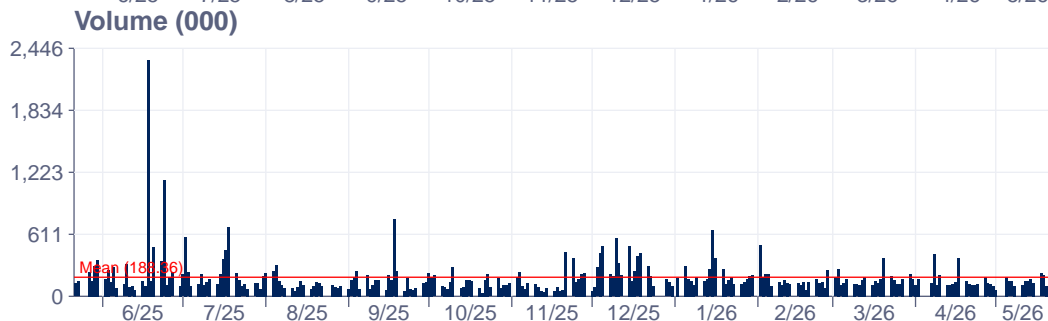
Price, Moving Averages & Volume



7.8 Frasers Group PLC is currently trading at 7.11 which is 7.1% above its 50 day moving average price of 6.64 and 2.9% above its 200 day moving average price of 6.91.

7.1 FRAS:LN is currently 7.7% below its 52-week high price of 7.70 and is 15.0% above its 52-week low price of 6.19. Over the past 52-weeks, FRAS:LN is up 0.2% while on a calendar year-to-date basis it is up 4.9%.

6.5 The Relative Strength Index (RSI) indicator for FRAS:LN is currently 64.16. An RSI value of 70 and above is considered overbought and 30 and below oversold.

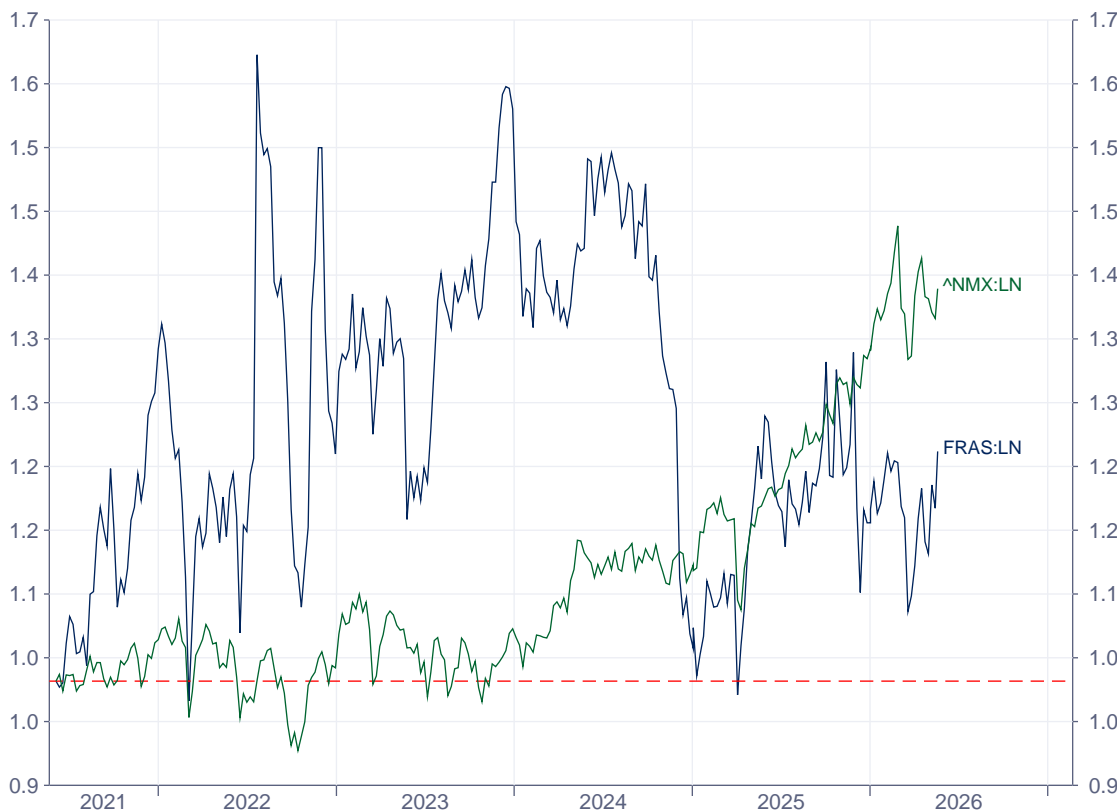

Frasers Group PLC's cumulative annualized revenue growth rate over the charted period is 1.6%. This compares to cumulative annualized growth of -0.1% over the past 3 years.



Frasers Group PLC's cumulative annualized EPS growth rate over the charted period is 8.1%. This compares to cumulative annualized growth of 15.2% over the past 3 years.



Frasers Group PLC's net profit margin of 8.9% is 1.7% above the period's mean net margin of 7.2%. During the charted period, the observed net profit margin high and low were 9.0% and 5.3% respectively.



Frasers Group PLC's return on equity of 21.9% is 2.7% below the period's mean return on equity of 24.6%. During the charted period, the observed ROE high and low were 34.4% and 14.0% respectively.

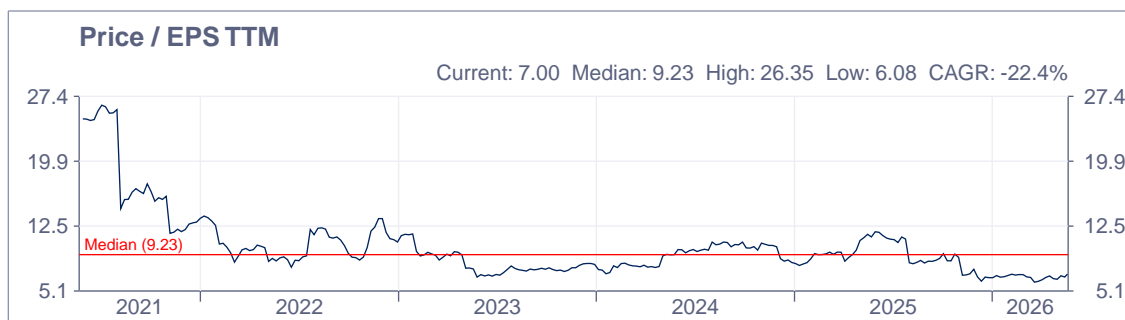

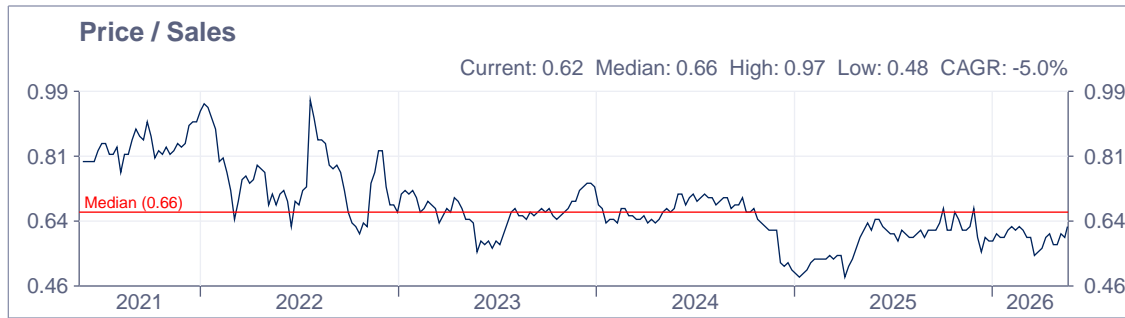

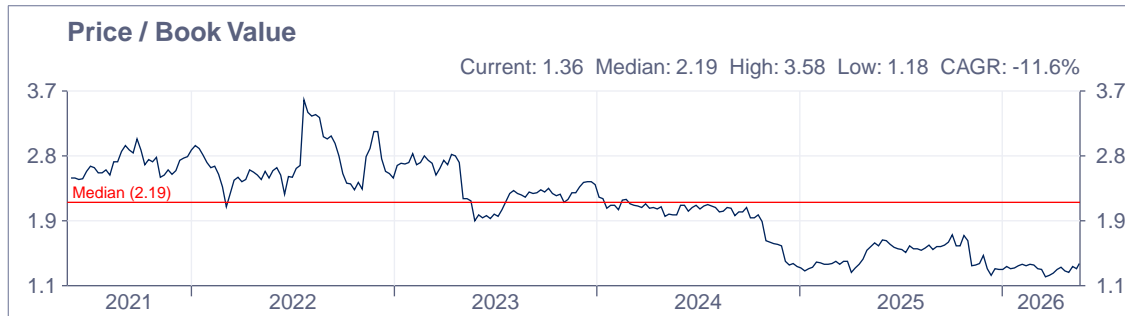

Frasers Group PLC is trading at 7.00 times its EPS generated during the latest fiscal year. This multiple is below the historically observed median of 9.23, while high and low observations have been 26.35 and 6.08.



Frasers Group PLC is trading at a Price to Sales ratio of 0.62 based on sales generated during the latest fiscal year. This ratio is below the historically observed median ratio of 0.66, while high and low observations have been 0.97 and 0.48.



Frasers Group PLC is trading at a Price to Book ratio of 1.36 based on book value at the latest fiscal year end. This ratio is below the historically observed median of 2.19, while high and low observations have been 3.58 and 1.18.



Frasers Group PLC has a Free Cash Flow Yield of 6.34% based on free cash flow generated during the latest fiscal year. This value is above the historically observed median yield of 5.33%, while high and low observations have been 10.75 and 0.00.

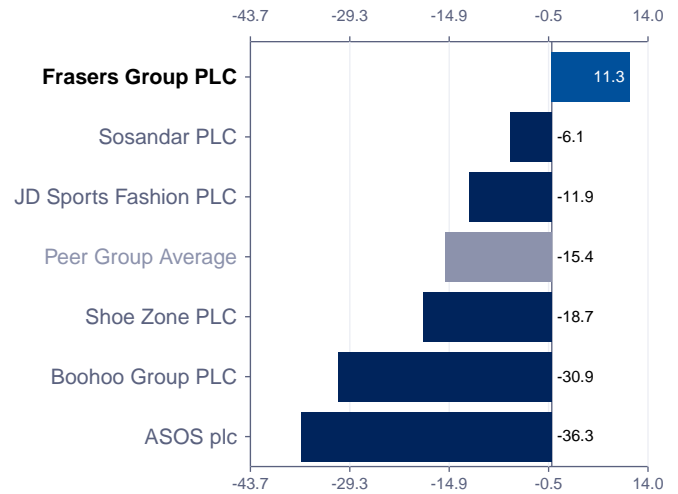

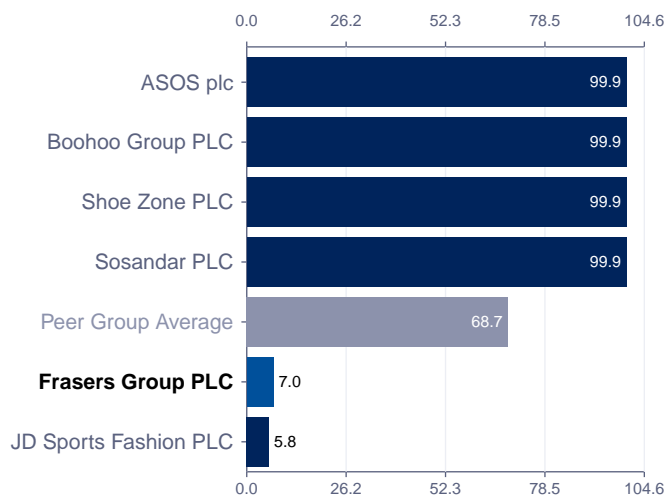
Price Change Year to Date %



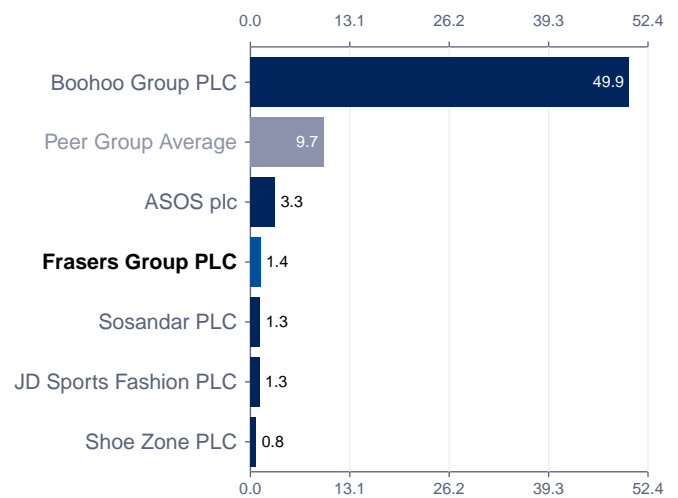
Price Change Last Calendar Year %



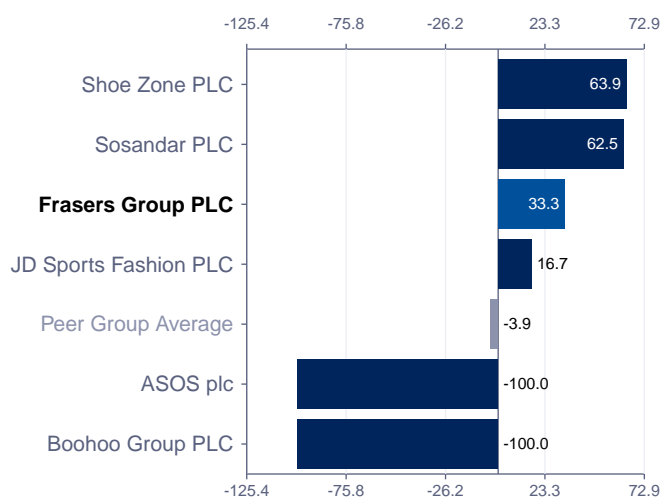
Price / EPS TTM



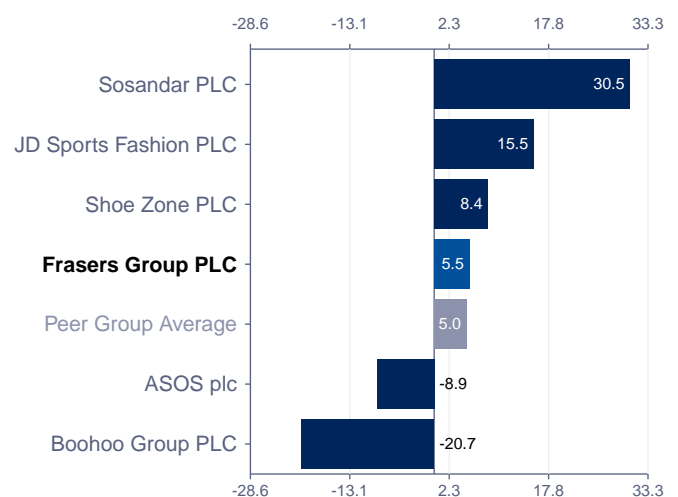
Price / Book Value

Market Value - Weekly Price times latest Shares Outstanding times any applicable ADR factor.

Revenue - Sum of the last four quarters of Revenues.

Revenue Per Share - Sum of the last four quarters of Total Revenue divided by Weighted Average Shares Outstanding.

Normalized EPS LFY- EPS excluding non-recurring, non-operating items, fiscal year aligned TTM value.

60-Day Average Volume (000) - The average of the last 60 daily volume values in thousands of shares.

Price 52-Week High - The high closing price from the last 52 weeks of daily closing prices.

Price 52-Week Low - The low closing price from the last 52 weeks of daily closing prices.

Price / 52-Week High - Latest price divided by the high price from the past 52 weeks of daily closing prices.

Price / 52-Week Low - Latest price divided by the low price from the past 52 weeks of daily closing prices.

50-Day Average Price - Mean of last 50 daily closing prices.

200-Day Average Price - Mean of last 200 daily closing prices.

Price / 50-Day Average Price - Latest closing price divided by mean of last 50 daily closing prices, as a percentage.

Price / 200-Day Average Price - Latest closing price divided by mean of last 200 daily closing prices, as a percentage.

Relative Strength Index - Relative Strength Index or RSI measures the magnitude of gains over a given time period against the magnitude of losses over that period. The equation is $RSI = 100 - 100 / (1 + RS)$ where $RS = (\text{total gains} / n) / (\text{total losses} / n)$ and $n = \text{number of RSI periods}$. In this item, 14 days is used and one year of daily prices are considered. A value of 30 or below may imply oversold and 70 or above may imply overbought.

Price Volatility - The standard deviation of the last 20 days of daily closing prices.

Sharpe Ratio - The 5 year average of the excess monthly return over the risk - free rate(1 - month T - bill) over the 5 year standard deviation of the same series.

Sortino Ratio - The same calculation as the Sharpe Ratio but with positive excess returns set to zero for the standard deviation denominator, so only negative volatility weighs in.

Dividends Per Share TTM - Sum of the last four quarters of Dividends Per Share.

Payout Ratio - Dividends Per Share TTM divided by Normalized EPS TTM.

Dividend Yield TTM % - Sum of the last four quarter of Dividends Per Share divided by Weekly Price.

EBITDA - Sum of the last four quarters of EBITDA (Operating Income + Depreciation & Amortization).

Free Cash Flow - Sum of the last four quarters Net Cash from Operations minus Capital Expenditures (Purchase of Property, Plant & Equipment), from the Cash Flow Statement.

Book Value Per Share - Total Common Equity last quarter divided by Shares Outstanding last quarter.

Gross Margin % - Sum of the last four quarters Gross Profit divided by the sum of the last four quarters Revenues.

EBITDA Margin % - Sum of the last four quarters EBITDA divided by the sum of the last four quarters Revenues.

Pre-Tax Margin % - Sum of the last four quarters of Earnings Before Taxes divided by sum of the last four quarters Revenues.

Net Profit Margin % - Sum of the last four quarters of Normalized EPS divided by sum of the last four quarters Revenues Per Share.

Return on Equity % - Sum of the last four quarters of Normalized EPS divided by the average of the last four quarters Book Value.

Return on Capital % - Sum of the last four quarters of Normalized EPS divided by the average of the last four quarters Total Capital Per Share.

Return on Assets % - Sum of the last four quarters of Normalized EPS divided by the average of the last four quarters Total Assets Per Share.

Price / EPS TTM - Weekly Price divided by the sum of the last four quarters of Normalized EPS (capped at 99.9).

Price / Sales - Weekly Price divided by Revenues Per Share TTM.

Price / Book Value - Weekly Price divided by Book Value Per Share last quarter. Book Value Per Share is Total Common Equity last quarter divided by Shares Outstanding last quarter (capped at 49.9).

Free Cash Flow Yield % - Free Cash Flow Per Share TTM divided by Weekly Price.

Enterprise Value - Market Value plus Total Debt last year plus Preferred Equity last year minus Cash & Cash Equivalents last year.

Enterprise Value / Sales - Enterprise Value divided by the sum of the last four quarters of Revenue.

Enterprise Value / EBITDA - Enterprise Value divided by EBITDA TTM.

Enterprise Value / EBIT - Enterprise Value divided by trailing four quarters of Operating Income.

Enterprise Value / Free Cash Flow - Enterprise Value divided by the sum of the last four quarters of Free Cash Flow.

Russell 1000 Index - The largest 1,000 stocks by market cap, the index comprehensively covers the US large cap universe.
