3i Infrastructure is an investment company. Co. invests in infrastructure businesses and assets. Co.'s portfolio consisted of Elenia, an electricity distribution; Anglian Water Group, a water utility; Oystercatcher, an oil product storage terminal; Cross London Trains, a passenger train fleet; ESVAGT, an emergency rescue and response vessels and wind farm maintenance support vessel; Infinis, a generator of electricity from landfill gas; TCR, ground support equipment in airport; Wireless Infrastructure Group, communication tower; and Valorem, an onshore wind developer. Co. invests in various sectors, such as utilities, transportation/logistics, natural resources/energy, and communications.

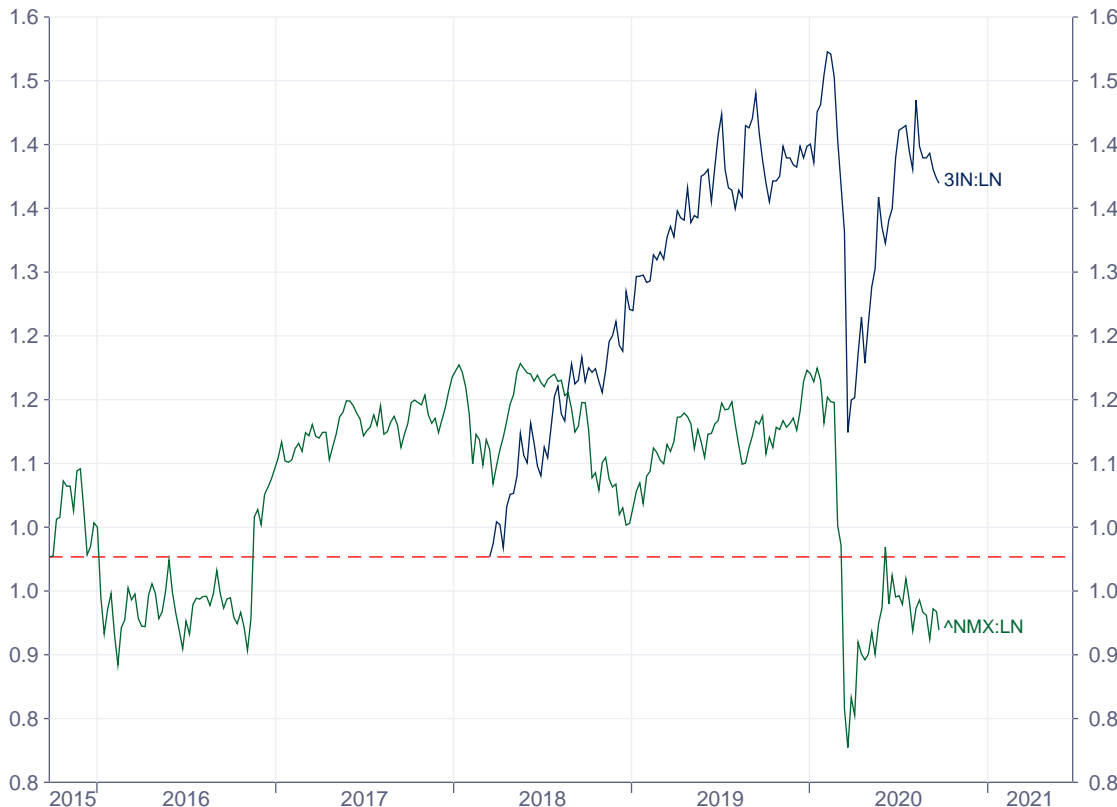

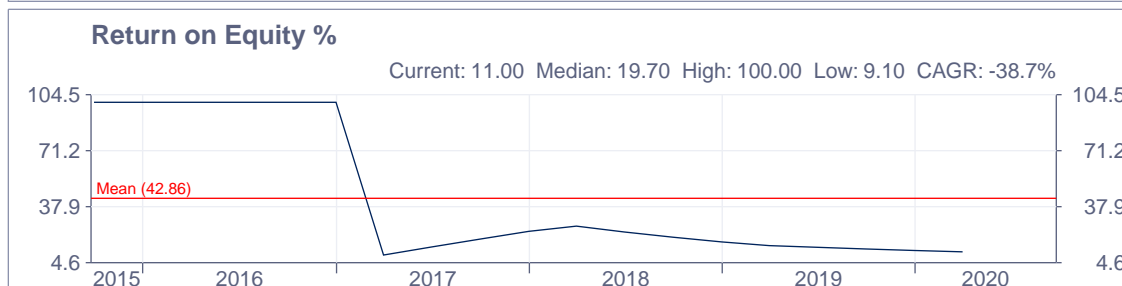
3I Infrastructure PLC's cumulative annualized revenue growth rate over the charted period is 0.8%. This compares to revenue growth of -21.2% last fiscal year and cumulative annualized growth of 3.0% over the past 3 years.



3I Infrastructure PLC's cumulative annualized EPS growth rate over the charted period is -66.3%. This compares to EPS growth of -17.2% last fiscal year and cumulative annualized growth of 21.0% over the past 3 years.



3I Infrastructure PLC's net profit margin last fiscal year of 85.2% is 1354.7% below the period's mean net margin of 1439.8%. During the charted period, the observed net profit margin high and low were 7143.9% and 54.7% respectively.



3I Infrastructure PLC's return on equity of 11.0% is 31.9% below the period's mean return on equity of 42.9%. During the charted period, the observed ROE high and low were 100.0% and 9.1% respectively.

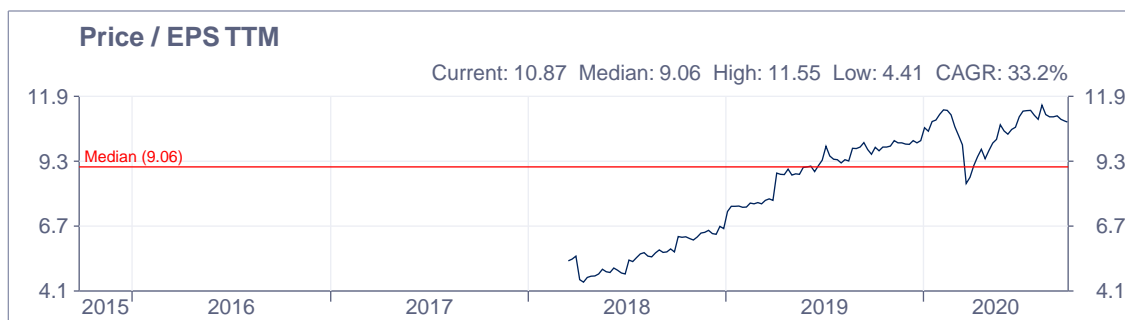

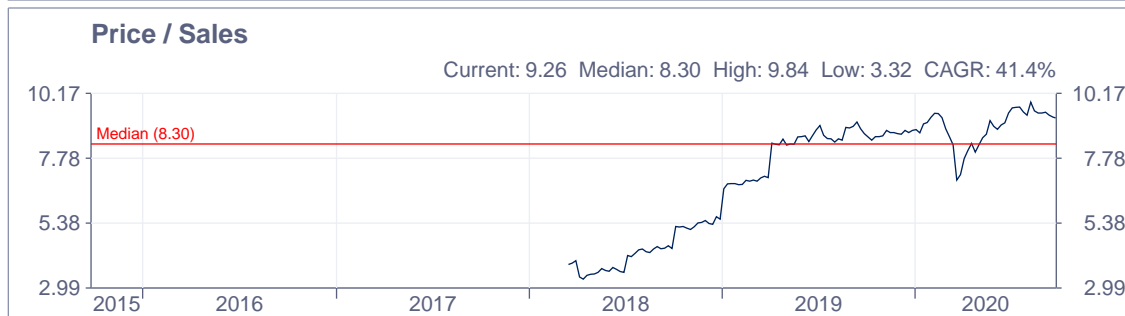

3I Infrastructure PLC is trading at 10.87 times its EPS generated during the latest fiscal year. This multiple is above the historically observed median of 9.06, while high and low observations have been 11.55 and 4.41.



3I Infrastructure PLC is trading at a Price to Sales ratio of 9.26 based on sales generated during the latest fiscal year. This ratio is above the historically observed median ratio of 8.30, while high and low observations have been 9.84 and 3.32.



3I Infrastructure PLC is trading at a Price to Book ratio of 1.13 based on book value at the latest fiscal year end. This ratio is below the historically observed median of 1.19, while high and low observations have been 1.34 and 0.94.

## Dividend Growth and Yield



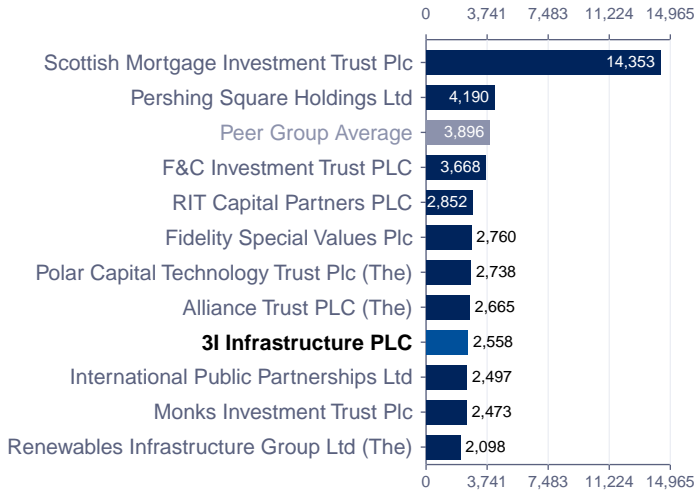

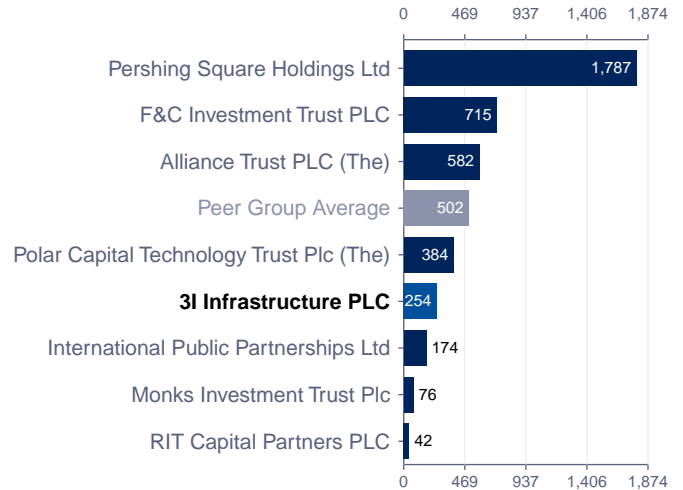

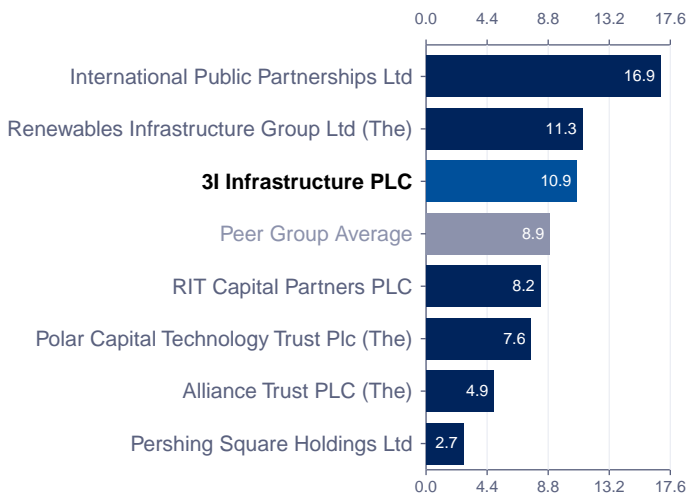

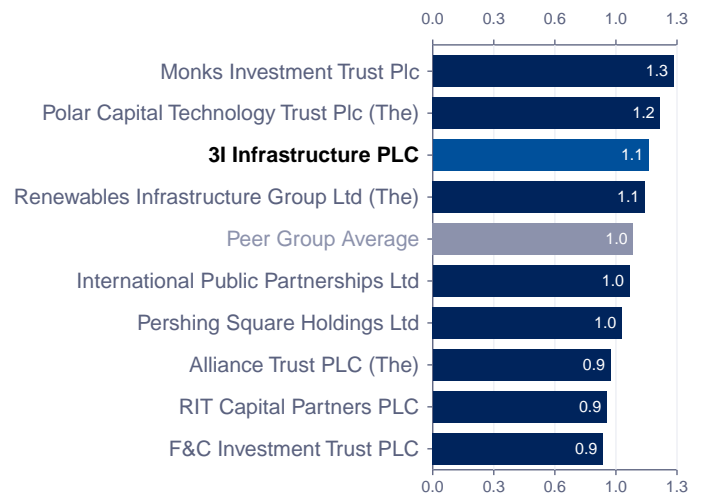
**Revenue LFY (M)**



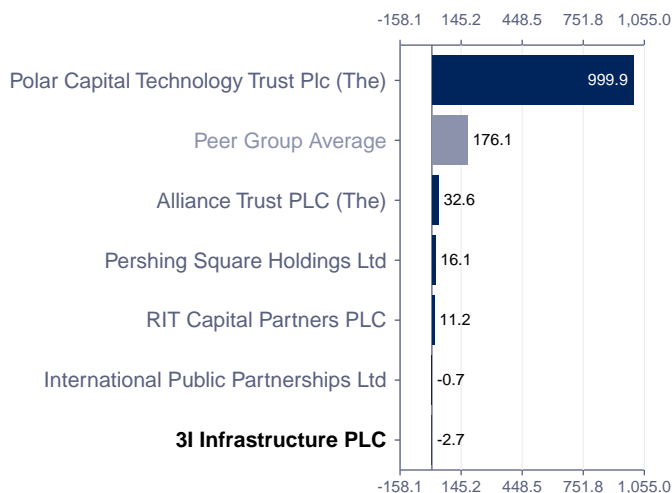
**Price / EPS TTM**



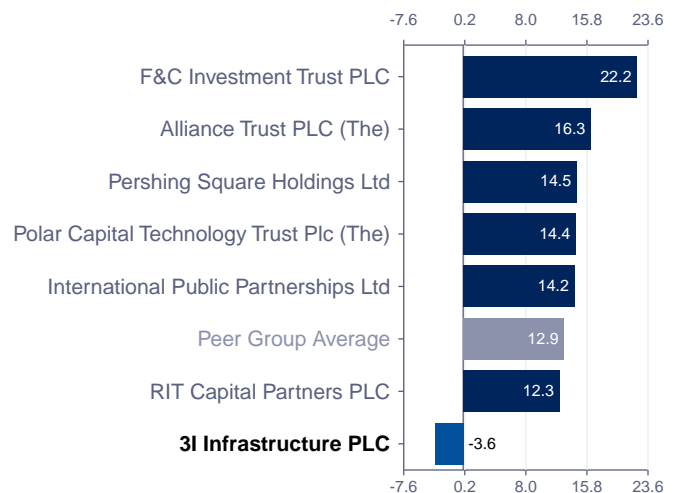
**Price / Book Value**

In this item, 14 days is used and one year of daily prices are considered. A value of 30 or below may imply oversold and 70 or above may imply overbought.
<b>Price Volatility</b>	- The standard deviation of the last 20 days of daily closing prices.
<b>Sharpe Ratio</b>	- The 5 year average of the excess monthly return over the risk - free rate(1 - month T - bill) over the 5 year standard deviation of the same series.
<b>Sortino Ratio</b>	- The same calculation as the Sharpe Ratio but with positive excess returns set to zero for the standard deviation denominator, so only negative volatility weighs in.
<b>Dividends Per Share TTM</b>	- Sum of the last four quarters of Dividends Per Share.
<b>Payout Ratio</b>	- Dividends Per Share TTM divided by Operating EPS TTM.
<b>Dividend Yield TTM %</b>	- Sum of the last four quarter of Dividends Per Share divided by Weekly Price.
<b>EBITDA</b>	- Sum of the last four quarters of EBITDA (Operating Income + Depreciation & Amortization).
<b>Free Cash Flow</b>	- Sum of the last four quarters Net Cash from Operations minus Capital Expenditures (Purchase of Property, Plant & Equipment), from the Cash Flow Statement.
<b>Book Value</b>	- Total Common Equity last quarter divided by Shares Outstanding last quarter.
<b>Book Value Per Share</b>	- Total Common Equity last quarter divided by Shares Outstanding last quarter.
<b>Gross Margin %</b>	- Sum of the last four quarters Gross Profit divided by the sum of the last four quarters Revenues.
